## SCHOOL BUS SERVICE UNDERSTANDING AND FINANCIAL AGREEMENT

This to inform you the execution of the **SCHOOL BUS SERVICE UNDERSTANDING AND FINANCIAL AGREEMENT** (the "Service Agreement") between **R TRANSPORT** with address at 18 Rimas St., Project 2 Quezon City (the "Bus Operator") and the parents / guardians of the students those whose names are indicated below, under the following terms and conditions:

**Duration.** This Service Agreement is valid for the current Schools year while the student(s) are enrolled **EUROPEAN INTERNATIONAL SCHOOL**. (the "School")

Requests for suspension / cancellation of the school bus service must be filled in writing to the Bus Operator, with copy to the EIS administrator not less than thirty (30) days prior to the date of affectivity.

- All parties confirm that they have received a copy of the bus handbook and have read it.
- All parties agree to abide by the principles set forth in this agreement and understanding that any breach of the said rules and principles may result in certain consequences:
  - 1<sup>st</sup> offense - warning,
  - 2<sup>nd</sup> offense - exclusion from the following trip home,
  - 3<sup>rd</sup> offense - one week suspension or up to expulsion (depending on the gravity).
- All parties agree to support and submit to the decisions of the School with regard to the application of the above consequences arising from a student discipline problem. It is understood that the authority of the School does not interfere with the management of the bus service provider.
- All parties acknowledge that the European International School (EIS Inc.) and its subsidiaries (LFM / GESM) are free from any all claims, damage or liabilities arising from any and all incidents relating to this Service Agreement, which is limited from the time bus riders board the bus until they disembark from the same upon arriving at their place of destination. Furthermore, they acknowledge that the Bus Operator is an independent contractor which is not an employee nor agent acting for or behalf of the School.
